Inspection Overview:

At approximately 0910 hrs, 5 Aug 2019, the injured worker (I/W) and 2 other workers were moving metal mesh construction fencing in order to complete landscaping. The trio had piled the fence panels (27) on a wooden pallet and were using a John Deere backhoe with forks attached to move the pallet. When turning left from the southbound lane of Norte Dame Av into the P3 parking lot, the load shifted; and the fence panels fell on the roadway.

While the trio were piling the fence panels back onto the pallet, the I/W lost his balance, and tripped on a nearby curb. 3-4 panels fell on him, and he sustained a suspected head injury from either the fall, or the panels. The I/W was transported to St Martha's Hospital in Antigonish, and then transferred via Life Flight to Halifax.

The I/W is employed by G. GRAHAM LANDSCAPE CONSTRUCTION Ltd. The company is sub-contracted to Ellisdon Construction, who are contracted to the University to construct a new building on the campus.

On the morning of the incident, the workers met with company supervisors from the employer and Ellisdon. It was decided that the employees would move the fencing to facilitate landscaping. This was not part of the worker's normal duties, as they had only done this task once or twice before. Additionally, the injured worker was operating the backhoe. He is relatively new to the task, and was being coached by a co-worker.

Measurements of the fencing showed that it was larger in dimension than the pallet. The fence panels are approximately 116"x74.5". The pallet measures approximately 72"x39". The fencing was not strapped or secured to the pallet, and the forks on the backhoe appeared to be off-centre.

Additionally, during initial inspection of the worksite, it was noted that although the workers had been performing work on or in proximity to a roadway, no evidence of any type of traffic control measures were in place.

An employer must ensure that construction, maintenance or utility work is not conducted at a temporary highway workplace until the employer adopts 1 of the following as a code of practice for the work:

- (a) the Temporary Workplace Traffic Control Manual;
- (b) a written safe-work procedure, approved in writing by the Director, that provides for an adequate level of safety in relation to the general considerations for traffic control set out in the Temporary Workplace Traffic Control Manual, including all of the considerations set out in subsection (2).

Powers of officers

For the purpose of ensuring compliance with this Act and the regulations and any order made thereunder, an officer may

- (a) at a reasonable hour of the day or night enter and inspect a workplace, conduct tests and make such examinations as the officer considers necessary or advisable;
- (b) require the production of records, drawings, specifications, books, plans or other documents in the possession of the employer that relate to the workplace or the health and safety of employees or other persons at the workplace and remove them temporarily for the purpose of making copies;
- (c) require the production of documents or records that may be relevant to the investigation of a complaint pursuant to subsection 46(1), and remove them temporarily for the purpose of making copies;
- (d) take photographs or recordings of the workplace and any activity taking place in the workplace:
- (e) make any examination, investigation or inquiry as the officer considers necessary to ascertain whether there is compliance with this Act and the regulations and any order made under them:

(f) inspect, take samples and conduct tests of samples, including tests in which a sample is destroyed, of any material, product, tool, equipment, machine or device being produced, used or found at the workplace for which the officer shall be responsible, except for a sample that has been destroyed, until the material, product, tool, equipment, machine or device is returned to the person being inspected;
